**All Sir Knights must submit their own registration form. Sir Knights should not be guests of others.**

Special Meal requests (if necessary, for Medical Reasons or Vegetarians) for Candidates, Sir Knights, Ladies and Guests must be shown on the Banquet Reservation Form.

Special Reminder:

A Candidate must have participated in the Charity-Unity-Fraternity (CUF) Exemplification and be a member in good standing to be eligible for the Exemplification of Patriotism, they must also **show a current travel card, for 2025** at the Exemplification.

**The Exemplification of Patriotism will be open to families and guests and the Ladies program will still be available.**

Please be sure to send only **COMPLETE** packets (Form 4, Banquet Reservation Form, and Check made payable to **Ty Simmons – Master**).

**Candidates** are expected to submit completed Form 4's and a copy of their travelling card with their council's Financial Secretary's signature, Banquet Reservation Form, along with payment **to the Assembly they will be joining**. In turn, the Navigator will submit the paperwork with his signature along with the Comptrollers signature, and payment to the District Secretary.

Faithful Navigators and Faithful Comptrollers must ensure all required information is completed including:

Membership Number, Member's Signature, Council Number, Name and FS signature.

Name, Number and location of the Assembly which the Candidate is joining.

Faithful Navigator Signature, Faithful Comptroller Signature.

Please print clearly on all documents.

Member email addresses can be printed in the space above the membership number. When filling out the Form 4, press hard so that the information transfers to the duplicate copies.

## APPROPRIATE DRESS CODE FOR CANDIDATES AND/OR OBSERVERS

Family members and guests will be allowed in the chamber to view the Exemplification.

### Exemplification Ceremony Notes

- This ceremony will take approximately 1 ½ hours. Doors will remain closed for the entire ceremony. Those that leave will be readmitted at an appropriate time.
- Cell phones must be on Silent or Off.
- No photography is permitted during the ceremony.
- Everyone must always remain in their seats. This includes adults and children.
- No food or beverages are allowed. Medical exceptions apply.

Faithful Navigators are also asked to ensure that all Assembly Members and Candidates are made aware that **PROPER ATTIRE MUST BE WORN** to the Exemplification.

### Candidates are expected to wear:

- **Business Suit** – either black, dark grey or dark blue in color.
- **Plain white shirt** - with lay down collars – no wing tip collars.
- **Black Tie** – plain black tie
- **Black Socks** – dress socks.
- **Black Dress Shoes** – **Only** black dress shoes are permitted.

### Clergy (candidates/observers) are permitted to wear:

- **Blacks or cassock**

### Sir Knights

- **Official Knights of Columbus uniform or dark suit, tie, black socks, and black dress shoes.**

### Ladies, Guests

- **Business professional attire (pant suits, dresses, skirts, suit, jacket, slacks).**

### Active Military, Police, Firefighters (candidates/observers) are permitted to wear:

- **Class A or Dress Uniform - instead of dark suit.**

**If proper attire as described above is not followed,  
you will not be permitted into the exemplification chamber.**

**Assemblies: When you issue a check for a candidate, a separate check is required for each Candidate and / or reservation with the name of the person shown on the check.**

If anyone writes a check for someone else, PLEASE make sure to note on the memo line who the payment is for. ALL checks must be payable to: **Ty Simmons, Master**.
